Moving to value-based care from a fee-for-service model may present challenges. This is where a tool like Cotiviti's Network Intelligence (formerly known as RowdMap) analytics software can help your practice.

We are offering Cotiviti Network Intelligence reports mainly to our contracted Medicare value-based primary care physicians (PCPs) as a means of support. Cotiviti provides analytics that can help your practice manage the care provided to Medicare patients. This information is not a substitute for the physician's medical judgment. About Cotiviti

Cotiviti uses publicly available fee-for-service data from the Centers for Medicare & Medicaid Services. Using this data, Cotiviti analyzes PCP practice patterns compared to their peers in a defined geographic area to highlight efficient and inefficient behavior.

Below are sample screenshots from Cotiviti's Network Intelligence platform to give you an idea of the analytics that Cotiviti can provide your practice. They illustrate how a hypothetical PCP group's referral patterns to cardiologists may be analyzed.

The graphic below shows the cardiology related referrals from this hypothetical PCP group broken down by the cardiology subspecialty. In this example, it shows 63.95% of the referrals to cardiologists go to interventional cardiologists, 23.64% to general cardiology, 9.44% to cardiac electrophysiology and 2.97% vascular surgery.

The graphic below takes a deeper dive into the specific interventional cardiology practices referred to by this hypothetical PCP group and shows the OVS for each interventional cardiology practice. If appropriate from a medical perspective, switching referrals from an interventional cardiology practice with a higher OVS to another with a lower OVS is one way your practice may be able to manage costs and improve the efficiency of the health care provided for your Medicare patients.




