What is the overall <u>deductible</u> ?	<u>In-Network</u> : \$250 Per Person/ \$500 Family. <u>Out-of-Network</u> : \$750 Per Person/\$1,500 Family. Does not apply to <u>preventive care</u>	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. <u>In-Network</u> Office visits and <u>preventive care</u> services.	You pay a set <u>copayment</u> per visit for <u>network</u> Physician office visits, while <u>Coinsurance</u> applies for most office visits to <u>out-of-network</u> physicians or other health care <u>providers</u> . Are there other <u>deductibles</u> for specific services?	Yes. \$250 <u>In-Network</u> Per Admission <u>Deductible</u> ; \$500 <u>Out-of-Network</u> . There are no other specific <u>deductibles</u> . What is the <u>out-of-pocket limit</u> for this <u>plan</u> ?	<u>In-Network</u> \$8,550 Per Person/ \$17,100 Family.	This <u>out-of-pocket limit</u> is the most you could pay in a year for covered <u>in-network</u> services. If you have other family members in this <u>plan</u> , they have to meet their own <u>out-of-pocket limits</u> until the overall family <u>out-of-pocket limit</u> has been met.
What is not included in the <u>out-of-pocket limit</u> ?	<u>Premium</u> , <u>balance-billed</u> charges, and health care this <u>plan</u> doesn't cover.	Even though you pay these expenses, they don't count toward the <u>out-of-pocket limit</u> .

### Your Rights to Continue Coverage:

If you lose coverage under the [plan](#), then, depending upon the circumstances, Federal and State laws may provide protections that allow you to keep health coverage. Any such rights may be limited in duration and will require you to pay a [premium](#), which may be significantly higher than the [premium](#) you pay while covered under the [plan](#). Other limitations on your rights to continue coverage may also apply.

### Does this Coverage Provide Minimum Essential Coverage?

The Affordable Care Act establishes a [minimum value standard](#) of benefits of a health [plan](#). The [minimum value standard](#) is 60% (actuarial value). This health coverage does meet the [minimum value standard](#) for the benefits it provides.
