

Attn: Value-Based Providers Time to Update Your Primary Care Provider Roster

It is time to update your roster of eligible value-based primary care physicians (PCPs) and physician extender PCPs. In preparation for 2022, we need your roster updates by **Nov. 30, 2021**. Updating your PCP roster helps us ensure your payments are accurate and consistent, and that your potential rewards, scorecard performance and other supporting reports are reconciled correctly in ProviderVista and the Quality and Efficiency Reporting Portal (QERP).

Update Your PCP Roster in Availity®¹

You must use Availity to update your roster. Ask your Availity Provider Account Administrator (PAA) to follow the instructions below and keep them handy for future reference:

- Log in to Availity at availity.com and select **Payer Spaces**, then **Florida Blue**.
- Click on the tile called, **Access, Manage, Verify Your Record**.
- Add your information in the required fields and click **Update My Information**.
- Click the **Add to Roster** button on the bottom of the page and add your PCPs or register new PCPs.
 - If you have PCPs who are no longer part of your practice, click on **End Affiliation** in the **Actions** column (same row as the impacted provider.)
 - To update a practitioner's specialty, click on **Update** in the **Actions** column (same row as the impacted provider.)

Important: **Nov. 30, 2021 is the deadline** for having your value-based physician roster approved for the 2022 measurement year. Please make sure your roster in Availity is up to date before then and that all your eligible PCP and physician extender PCPs are associated with your group's TIN.

Use Our Excel Spreadsheet to Validate Your Participating Value-Based Providers

We will send you an excel spreadsheet in October so you can verify we have correct information for your provider roster.

Important: Please be sure to use the excel spreadsheet we send you to validate information for your providers in the designated fields according to instructions we will provide. Eventually, this process will be automated to ensure data is current, and our members are assigned to your providers appropriately.
