## Adherence to Antipsychotic Medications for Individuals with Schizophrenia (SAA)

The Healthcare Effectiveness Data and Information Set (HEDIS<sup>®</sup>) helps us measure many aspects of performance. This tip sheet provides key details of the HEDIS measure for antipsychotic medications adherence for individuals with schizophrenia.

## What Is the Measure?

The measure monitors members age 18 years and older during the measurement year with schizophrenia or schizoaffective disorder who were dispensed and remained on an antipsychotic medication for at least 80% of their treatment period.

#### Note:

- Injections count as one dispensing event.
- The patient must have at least two dispensing events to be included in the measure.
- Visit types include telehealth and telephone.
- The treatment period runs from the prescription start through December 31 of measurement year.
